NEW BUSINESS - Discussion and possible action taken on the following:

a. Judith Deuel – Requesting permission to move in a portable building to be used as a guest cottage located at 9964 Treasure Drive

Ms. Deuel stated that at first she was wanting to move in a storage building to be converted into a guest cottage. But that it would be to much work, so she wanted to see if it would be ok to turn it into a pool house for her above ground pool. Mayor Bogue asked if anyone would be sleeping or living in the building and Ms. Deuel replied no.

- b. Mr. & Mrs. Howard Requesting permission to sale BBQ in Dollar General's parking lot.

They do a backpack drive, and they help furnish personal hygiene products for inmates in the prison system. And that Water Plant Manager, Rodney Garrett, has stated that TCEQ is now requiring that builders either have a master plumber put in the plumbing or have the plumbing inspected by a Master Plumber. Council Member Craig Kartye stated that he wanted to look into the remodel inspections, as he did not want to have to require someone that is just replacing a ceiling fan or redoing a room to have to pay extra for an inspection and hinder them from the repairs. And that he looked into the TCEQ requirements and spoke to someone from TCEQ and that he would like to discuss it more, because he was told that it's not required yet.
