Mayor's Message September 2022

GRANT MONEY: The City of Liverpool has received the Coronavirus Local Fiscal Recovery Fund- American Rescue Plan Act of 2021 grant. With this grant the City will be able to drill a 3rd water well. The Grant sets out certain usage guidelines for the Grant. After looking at the usage guidelines, City Council choice to have a new well drilled. Liverpool is growing with new homes, and a new well will help with that growth to keep up with the water supply demand. The project should be completed by 2024. We are looking into other grants that could help pay for road repairs in the City. City Council is in the process of evaluating the roads so that when we do have the funds available for road repairs, we can have a list of which roads need to be done first based off the evaluations.

AUDIT: The City of Liverpool had its yearly audit done and was presented in August at the August City Council meeting. The City received an unmodified audit rating, which is the highest rating that a City can receive.

FIRE DEPARTMENT: The City has been trying to get updates on what is happening with the Liverpool Volunteer Fire Department. I, along with Catherine Long, City Secretary, has made numerous phone calls to the ESD3, and to the Brazoria County Commissioners, all with the same response. ESD3 states that they cannot give out any information due to an ongoing investigation. Brazoria County Commissioners state that they have no power or control over ESD3. If any resident would like to voice their concerns and/or ask questions regarding the fire department, the ESD3 has their monthly meetings every 2nd Monday of the month at 6:30PM at the District's EMS Station located at 6931 Masters Road, Manvel, Texas 77578. The ESD3's phone number is 281-519-8779. The City is very concerned for the safety of our community and is working to try and get the fire department back open.

FOOD PANTRY: Food pantry is open Friday's from 10:00 AM – 12:00 PM. With the help of our generous community, we are able to help those in need. Just as a reminder, only residents of the Chocolate Bayou Community are able to receive food from the food pantry. Anyone coming to the food pantry MUST show proof of address with some form of identification card, and a utility bill, and the food pantry cannot give food to multiply people with the same address. Our Volunteers work hard to be able to help those in need. *"It's not how much we give but how much love we put into giving."* – Mother Theresa.
