Mayor Bogue Opened Public Hearing on proposed 2022-2023 Fiscal Year Budget.

PUBLIC HEARING ON PROPOSED 2022-2023 FISCAL YEAR BUDGET

NEW BUSINESS – Discussion and possible action may be taken following items:

a. Randy Hall - Bayou Oaks Subdivision

Mr. Hall presented Council with a map of the proposed subdivision and explained that its 230 and that there would be about 700 homes and that it would be either a MUD or PID and that it would pay for everything. He stated that he just wanted Council to think about it, that he is working with Brazoria County Drainage to solve drainage problems. Brazoria County has turned down the subdivision due to lot size. It is proposed 40-to-50-foot lot sizes. He also stated that Mayor Bogue has already stated that the City does not have the funds to support the subdivision, however he just wanted Council to think on it before making a decision. He also stated that the City would get tax revenue off the subdivision before the City would have to start maintaining it.

b. Yamilett Sweet – Request to put in manufactured home at 8331 Calhoun (CR 171)

Ms. Sweet stated that she wanted to put a manufacture home on the lot, that it's a brand-new home.

- c. Salvodor Salinas request to subdivide property located at 10289 Highway 35.

Mr. Salinas stated that he had gotten permission several years ago to subdivide his property into 3 parts, but now he wants to take 2 of the parts and replat it into one. He wants to have 2 properties, 1 is a 5-acre tract and the other is an 8-acre tract.

- d. Santos Figuero discuss problem with address sign of neighbor.

Mr. Figueroa stated that his neighbor (Mr. Felipe Orozco) has purchased property on 1st Street beside him, and that he has put on an address sign and that now everyone is confused as to Mr. Figuero's address. He asked Council if he could put up an address sign so that his address is visible to people looking for his home. Mayor Bogue stated that there was not a problem with him putting up an address sign on his property.

- e. Felipe Orozco discussion on putting gravel on a dedicated roadway, 1st Street, to have access to his property.

Council stated that only a little part of 1st Street was in the City, and that the part of 1st Street that his property was on is in Brazoria County. However, it is ok to put gravel on the section in the City, as long as Mr. Figuero was ok with it. Mr. Figuero stated that he was ok with Mr. Orozco placing rock on 1st Street.

f. Mark Ricketts – discussion of Riverhaven and ordinance violations at 8637 Riverhaven and 8703 Riverhaven

City Secretary, Catherine Long, stated that she had included all the correspondence between the City and the Ricketts. Council feels that the City should have a survey done on the property to establish the dedicated road easements, and to find any paperwork regarding the dedicated road easement.

AN ORDIANCED PROVIDING FOR THE ASSESSMENT, LEVY, AND COLLECTION OF AD VALORERM TAXES FOR THE CITY OF LIVERPOOL, TEXAS, FOR THE YEAR 2022, AND FOR EACH YEAR THERAFTER UNTIL OTHERWISE PROVIDED; PROVIDING THE DATE ON WHICH SUCH TAXES SHALL BE DUE AND PAYABLE; PROVIDING FOR PENALTY AND INTEREST ON ALL TEAXES NOT TIMELY PAID; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLECT HEREWITH, THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERTAIONS THAN LAST YEAR'S TAX RATE.
