CALL TO ORDER- Mayor Ric Bogue called meeting to order at 6:30 p.m.

ROLL CALL – Catherine Long called attendance. -All Council Members were present

NEW BUSINESS – Discussion and Possible Action may be taken on the following:

a. Ms. Bailey – requesting to subdivide property located at 5211 CR 196 (ETJ)

Mr. Bean was present along with Ms. Bailey. Mr. Bean stated that it is a total of 54 acres and that several family member, and close friends are all going in together to form an LLC to purchase the land. Once the land is purchased, they want to dissolve the LLC and subdivide the property into 5 parts. The subdivide will depend on how much each person put in, one family will get 18 acres, another 17 acres and a couple will get either 7 acres or 6 acres. He stated that he just wanted to make sure that it is possible before they move forward with the purchase. Brandon Middleton with Drainage stated that he would have to go to Brazoria County Drainage Department 5 first and get all the requirements from there. Mayor Bogue told Mr. Bean to go to Drainage first and then come back and Council would vote on it then.

Mayor Bogue stated that all Council Members should have the road evaluation form, and that he would like to get them back asap so that we can start on 2 more roads.

a. Tomas Flores – requesting to put roadway in for Peral Street off CR 171 to access his property.

Mayor Bogue stated that he did not see any way around not putting in some type of roadway. And that the trees would have to be cut down, and that he had idea how much that would cost. He asked Mr. Flores if the City cuts the trees could he put in a driveway access. Mr. Flores said that he could put in a driveway access and that he would help in any way he could. Mayor Bogue stated that the City would start looking into what needs to be done and the cost.

They stated that it would work with our current insurance and not take away from the current insurance and that the supplements could be offered to full-time and part-time employees. They also stated that the employees could pick and choose what programs they wanted.

d. FY 23/24 budget

CPA Phyllis Hurbst was present and stated that if anyone had any questions on the budget, or wanted to change anything on the budget to contact her and she would answer the questions or change what needed to be changed. She stated that no action needed to be taken.

e. FY 23/24 Taxes

CPA Phyllis Hurbst presented Council with the memo stating that the This year's no new revenue tax rate calculation would be \$.114452/100 or 11.4452 cents/100; and that the This year's voter approval tax rate calculation would be \$.125248/100 or 12.5248 cents/100. She stated that Council would be setting the rate at the meeting and explained that means that it is the number that they could not go over when setting the tax rate for FY 23/24. Council discussed not raising the rate.

- -Motion was made by Council Member Roland Agrella to set the tax rate at \$.114452/100

f. Discussion on enforcing RV ordinance

Mayor Bogue stated that Council needed to decide if the City is going to ban living in RVs all together or just from this point on. He stated that with the few people that are living RV's that there would be some push back from them, as they have been living in the RV for a long period of time. Council feels that each person living in a RV at the current time should be given 6 months to move. Council also feels that no more variances should be given to people to live in RVs while building their homes. Council also felt that more discussion was needed.

g. Discussion on Manufactured Homes Ordinance (2013-A)

Council members came to the agreement that the driveway for Manufactured homes should be, at the residences discretion, either 20 feet wide, or 20 feet long, and that it could either be 20 feet starting at the roadway to the home, or from the home to the roadway, and that if the driveway has to be longer than 20 feet, anything over 20 feet could be whatever the resident wanted to put down. Council also feels that the minimum thickness of the concrete driveway has to be at least 2 inches.

- -Motion was made by Council Member Roland Agrella to adopt the changes to ordinance 2023-C amending the driveway for ordinance 2013 A.
- -2nd by Council Member Nancie Bailley
- -All Approved
- h. Riverhaven Dedicated roadway possible actions for dedicated roadway. Possible abandonment of dedicated roadway and lost 1 107 of River Haven Estates
