NOTICE OF HEARING, THE CITY COUNCIL OF THE CITY OF LIVERPOOL, TEXAS WILL HOLD A PUBLIC HEARING ON THE PROPOSED ANNUAL BUDGET FOR THE FISCAL YEAR OF OCTOBER 1, 2023 TO SEPTEMBER 30, 2024. THIS BUDGET WILL RAISE TOTAL PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$0.00 AND THE PERCENTAGE OF THE INCREASE IS 0.00\$ AND OF THAT AMOUNT \$1492 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.

a. Basel Mujarkesh – Requesting to place a home and RV park at 2104 1st Street.

- b. Jesus Esparza Requesting information on building a home at 2306 4th Street.

Mr. Esparza explained that he wants to build a home at 2306 4th Street. He stated that there is already a home on the property, that he wants to build in between the existing home and the home next door. The home would be about 1600 sq feet. He stated that the property is divided into 3 sections, each section being about .7 acres. The City's Drainage Commissioner stated that he would first have to go to Brazoria County and find out if it's possible, with the setbacks. And that he really didn't think that it was feasible to build because as per City Ordinance, you must have a 1-acre lot to build a home. And if he built his house pad up, he would add to the flooding problem to his neighbor. Mayor Bogue stated that the city would not be giving any variance on lot size, and that it was not going to be possible to build any other homes on that lot. But that he could go ahead go to Brazoria County to see what they say, then come back to Council for a vote.

d. CONSIDERATION AN DPOSSIBLE ACTION TO APPROVE ORDINANCE 2023-02

AN ORDINANCE PROVIDING FOR THE ASSESSMENT, LEVY, AND COLLECTION OF AD VALOREM TAXES FOR THE CITY OF LIVERPOOL, TEXAS, FOR THE YEAR 2023/2024, AND FOR EACH YEAR THEREAFTER UNTIL OTHERWISE PROVIDED; PROVIDING THE DATE ON WHICH SUCH TAXES SHALL BE DUE AND PAYABLE; PROVIDING FOR PENALTY AND INTEREST ON ALL TAXES NOT TIMELY PAID; AND REPEALING ALL ORIDNANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH, THAT THE TAX RATE WILL NOT RAISE MORE TAXES FOR MAINTENANCE, AND OPERATIONS THATN LAST YEARS TAX RATE.

-Council Member Nancie Bailly stated, "I move that the property tax rate is not increased by the adoption of a tax rate of .114452 cents, which is effectively a 0.0 percent increase in the tax rate. This tax rate consists of .114452 cents for maintenance taxes."
